MEMORANDUM TO THE ACADEMIC AND EDUCATIONAL
EXCHANGE AGREEMENT

BETWEEN

GRADUATE SCHOOL OF ENGINEERING, HIROSHIMA UNIVERSITY, JAPAN
AND

MALAVIYA NATIONAL INSTITUTE OF TECHNOLOGY JAIPUR, INDIA

Graduate School of Engineering, Hiroshima University, Japan and Malaviya National Institute of Technology Jaipur, India hereby agree to determine each item concerning the implementation of the undergraduate and graduate student exchange (hereinafter referred to as “exchange students”), based on Article 1, Paragraph 3, of the Agreement on Academic and Educational Exchange which both institutions concluded.

1. The number of students exchanged shall not exceed two per semester. Exchange students shall be permitted to stay at the host institution no longer than one year.
2. Exchange students will not be subject to examination, admission, or tuition fees at the host institution.
3. Exchange students shall be given authorization and appropriate documents by the host institution to apply for visas for the length of time equivalent to the exchange term in the country where the host institution is located.
4. At Hiroshima University, undergraduate exchange students shall be accepted with the status of Special Auditing Students and graduate students shall be accepted with the status of Special Auditing Students or Special Research Students.
At Malaviya National Institute of Technology Jaipur, India, exchange students shall be accepted with the status of Special Research Students.

Selection of exchange students will be subject to the authority and discretion of the host institution.

5. Exchange students may enroll in all courses (classes) offered by each institution, except specific courses determined by the host institution. However, Special Research Students are not eligible to enroll in classes offered by Hiroshima University.
6. Both institutions agree to endeavor to transfer credits earned by exchange students at the host institution, subject to their regulations and procedures.
7. Both institutions shall endeavor to help exchange students to find appropriate housing.

8. Concerning the implementation of the exchange, particulars shall be discussed and agreed upon by both institutions when necessary.
9. This memorandum shall commence on the day both parties have signed this memorandum and shall remain effective for five years. This memorandum shall be automatically renewed at the end of the five-year term unless one or both of the institutions propose otherwise. Both institutions shall send written notice and consult one another at least one year prior to revision or termination of this memorandum.

AGREEMENT ON ACADEMIC AND EDUCATIONAL EXCHANGE
BETWEEN
GRADUATE SCHOOL OF ENGINEERING, HIROSHIMA UNIVERSITY, JAPAN
AND

MALAVIYA NATIONAL INSTITUTE OF TECHNOLOGY JAIPUR, INDIA

Graduate School of Engineering, Hiroshima University, Japan and Malaviya National Institute of Technology Jaipur, India hereby agree to establish an academic and educational exchange agreement in order to promote mutual understanding between the two countries and between the two institutions through educational and academic collaboration and exchange, and to contribute to the advancement and progress of learning.

Contents of the Exchange Programs

1. Both institutions agree to cooperate in the following areas:
 - (1) Promotion of joint research
 - (2) Exchange of faculty members and administrative staff
 - (3) Exchange of undergraduate and graduate students
 - (4) Exchange of research outcomes, academic publications, and other academic information
 - (5) Other academic and educational exchange programs approved as suitable by both institutions

Implementation of the Exchange Programs

2. The areas listed above shall be implemented following mutual consultation.

Term of the Agreement

3. This agreement shall become effective when the representatives of both institutions sign below and shall remain effective for five years. The agreement shall be automatically renewed at the end of the five-year term unless one or both of the institutions propose otherwise.

Revision and Termination of the Agreement

4. Both institutions shall send written notice and consult with each other at least one year prior to revision or termination of the agreement.

Compliance with the Laws

5. All activities developed under this agreement must take place in compliance with all applicable laws, customs, regulations and standards of each university, its country and region.

Language Used

6. This agreement shall be established in English and executed in duplicate, with each party retaining one copy thereof.

Should any questions on any part of this agreement arise, both institutions must consult with one another to find a solution.
